The Nasdaq Listing Center is a digital gateway for issuers to list financial instruments on Nasdaq's markets. It supports a streamlined, secure, and scalable process for submitting listing applications and related documentation. We provide customized listing solutions for both program issuers and standalone issuers, making the listing process seamless.

Application Process

- **Account Setup:** Each user must create an account to access the [Listing Center](#).
- **Application Management:** Users can manage multiple applications under one account and share them with collaborators.
- **Submission Flexibility:** Applications can be completed in stages or all at once.
- **Post-Submission:** After submission, only document uploads are allowed—no further edits to the application form.

Communication & Confirmation

- **Acknowledgment Email:** Sent immediately.
- **Approval Email:** Includes links to the Exchange Notice and final Listing Form.

Methods for Data Input

Excel Template Upload

- Download and fill out Nasdaq's standardized Excel template.
- Upload directly to the Listing Center.
- Ideal for bulk submissions or when working offline.

Web Form Entry

- Use the intuitive web interface to manually input listing data with intelligent logic and auto-filled fields from regulatory codes.
- Real-time validation and guidance ensure accuracy.
- Best suited for single or occasional listings.


API Connectivity
