Power Trading Results

In November 2019, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 76.8 TWh. The share of Order Book traded power was 36.6 TWh which includes 1.4 TWh from German Power.

Electricity Certificates Trading Results

In November 2019 the total volume of traded and cleared Electricity Certificates was 1.299 million El-Certs.

Carbon Trading Results

In October 2019 the total volume of traded and cleared EUAs was 0.160 million tonnes.
