## **Power Trading Results**

In June 2020, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 70.5 TWh. The share of Order Book traded power was 36.1 TWh which includes 1.0 TWh from German Power.

## **Electricity Certificates Trading Results**

In June 2020 the total volume of traded and cleared Electricity Certificates was 803 million EI-Certs.

## **Carbon Trading Results**

In June 2020 the total volume of traded and cleared EUAs was 0.090 million tonnes.
