Power Trading Results

In July 2020, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 39.8 TWh. The share of Order Book traded power was 22.3 TWh which includes 0.5 TWh from German Power.

Electricity Certificates Trading Results

In July 2020 the total volume of traded and cleared Electricity Certificates was 337 million EI-Certs.

Carbon Trading Results

In July 2020 the total volume of traded and cleared EUAs was 0.209 million tonnes.
