Power Trading Results

In March 2021, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 74.7 TWh. The share of Order Book traded power was 42.2 TWh which includes 1.1 TWh from German Power.

In March 2021, the total volume of traded and cleared Electricity Certificates was 305 thousand El-Certs.

Carbon Trading Results

In March 2021, the total volume of traded and cleared EUAs was 0.024 million tonnes.
