## Disciplinary Cases

### **Nasdaq Stockholm: DISCIPLINARY CASE 2022:01 – LSTH Svenska Handelsfastigheter AB**

The Disciplinary Committee of Nasdaq Stockholm found that LSTH Svenska Handelsfastigheter AB ( "LSTH") had breached Nasdaq Stockholm's Rule Book for Issuers of Fixed Income Instruments (the "Rulebook") and therefore ordered LSTH to pay a fine of SEK 1,500,000.

The Disciplinary Committee concluded that the Swedish Securities Council (ruling 2021:43) had found that LSTH had violated item II.3 of the Takeover rules for certain trading platforms issued by the Swedish Corporate Governance Board, by not including information about at what level of a possible competing bid that a certain shareholder in the target company would not be bound by an undertaking to accept LSTH's bid, in its announcement of a takeover bid to the shareholders of Tre Kronor Property Investment AB.

Against that background, the Disciplinary Committee concluded that LSTH had breached good practice in the stock market and consequently also the Rulebook. The Disciplinary Committee took a serious view of LSTH 's violation and consequently ordered LSTH to pay a fine of SEK 1,500,000.

### **Nasdaq Stockholm: DISCIPLINARY CASE 2022:03 – Newton Nordic AB**

The Disciplinary Committee of Nasdaq Stockholm AB (the "Exchange") found that Newton Nordic AB ("Newton Nordic") had breached the Nasdaq First North Growth Market Rulebook (the "Rulebook") and therefore decided that Newton Nordic's shares would be delisted from Nasdaq First North Growth Market.

The Disciplinary Committee concluded that Newton Nordic, through the disclosure of its interim report for the third quarter of 2021, had breached article 17 of the EU Market Abuse Regulation ("MAR"), and consequently item 4.1 of the Rulebook, as the content of the report misleadingly gave the impression that a planned acquisition had already been completed, when in fact no agreement for the acquisition had been entered into.

Additionally, the Disciplinary Committee concluded that other disclosures made by Newton Nordic in relation to the planned acquisition, besides the interim report, had also been contradictory and unclear, and that Newton Nordic had breached article 17 of MAR and item 4.1 of the Rulebook in this regard as well.

The Disciplinary Committee further concluded that Newton Nordic had not provided the Exchange with correct and reliable information necessary to the Exchange's surveillance of Newton Nordic upon request, and that Newton Nordic had thereby breached item 4.8 of the Rulebook.

Given that Newton Nordic had repeatedly shown an inability to act in accordance with the Rulebook, the Disciplinary Committee concluded that Newton Nordic's management lacked the appropriate qualifications as set out in item 2.3.4 of the Rulebook as well as sufficient capacity for providing information to the market as set out in item 2.3.5 of the Rulebook.

In summary, the Disciplinary Committee took a particularly serious view of Newton Nordic's breaches, which had been likely to seriously damage the confidence in the Exchange and the securities markets in general. Upon an overall assessment, the Disciplinary Committee found that Newton Nordic's shares would be delisted from Nasdaq First North Growth Market.
