General Information From Surveillance

New Delisting Procedure on Nasdaq First North Growth Market

Effective July 1, 2025, an update of the Nasdaq First North Growth Market Rulebook for Issuers of Shares entered into force, enhancing the Exchange's authority to make administrative decisions regarding the delisting of an issuer's financial instruments on Nasdaq First North Growth Market.

According to the newly added wording in item 8.2.7 of the rulebook, the Exchange is now authorized to delist an issuer that fails to make payment in accordance with the rulebook. This includes, but is not limited to, non-payment of annual fees, issuer fees, or sanctions imposed by the Disciplinary Committee.

The Exchange may proceed with a delisting decision unless such action is deemed inappropriate in light of investor or market interests, or if it would otherwise conflict with applicable legislation. The updated procedure applies in cases where issuers have been reminded of their outstanding debts but have not taken steps to resolve them.

Changes to issuer requirements on buy-backs on Nasdaq Stockholm

As of July 7, 2025, Nasdaq Stockholm has updated the Nasdaq Nordic Main Market Rulebook for Issuers of Shares concerning share buy-backs. The revised provisions are set out in Supplement D, Part H, item 31 ii (a) - (b) and iii and relate specifically to the price restrictions applicable to an issuer's repurchase of its own shares. These changes align the relevant rules with the requirements of the Commission Delegated Regulation (EU) 2016/1052, commonly referred to as the "safe harbour regime".

The revised price restriction states that, when executing transactions under a buy-back programme, the issuer must not purchase shares at a price higher than the greater of: (i) the last independent trade price, and (ii) the highest current independent purchase bid on the trading venue where the transaction takes place. This applies even when the shares are traded across multiple trading venues.

Additionally, restrictions on transactions in auction phases have been added in item 31 iii.

Updates to the Nasdaq Nordic Guidance on the Requirements for Products Referencing Crypto Assets

In June 2025, the Nasdaq Nordic Exchanges (Sweden, Denmark, and Finland) updated their Nasdaq Nordic Guidance on the Requirements for Products Referencing Crypto Assets ("Crypto Guidelines"). This revision allows for the inclusion of additional crypto assets as underlying assets for Exchange Traded Notes ("ETN").

ETNs with crypto assets as underlying assets must comply with the relevant Nasdaq Main Market Exchange Traded Notes Rulebook as well as the Nasdaq Nordic Crypto Guidelines. The Crypto Guidelines complement the rulebooks and outline specific requirements that must be met to admit an ETN with crypto assets as underlying assets. Previously, only crypto assets included in the Nasdaq Crypto Index ("NCI") were eligible as underlyings according to the Crypto Guidelines. The revised guidelines now include additional requirements for crypto assets outside the NCI, focusing on aspects such as pricing, liquidity, and trading availability.

Management of Member Contact Information in Member Portal

To ensure that critical information reaches the appropriate teams and to improve the accuracy of member contact details, the European Market Surveillance team has updated the structure of contact details in Member Portal. The revised setup includes three new standardized contact types for Equities, Derivatives and Fixed Income:

- Market Surveillance (Group Contact)
- Compliance (Group Contact),
- Additional Trading Contact (Group/Person).

These categories were selected to better reflect the operational responsibilities and support effective communication with Exchange members.

These changes will be applied to the Exchange-related contact lists, while Clearing-only list will remain unchanged. As part of the update, the Exchange members will be responsible for maintaining their own contact details directly in the portal. Members will be contacted and asked to review and update their contact details on an annual basis.

Disciplinary Committee Decisions Stockholm

Decision by the Disciplinary Committee regarding ELLWEE AB (publ)

The Disciplinary Committee of Nasdaq Stockholm found that ELLWEE AB (publ) had breached the rules of Nasdaq First North Growth Market and therefore ordered the company to pay a fine equivalent to three annual fees.

The company carried out a partially guaranteed rights issue at the end of 2023. The company announced the outcome of the issue on December 18, 2023. The press release stated, among other things, that the guarantor had subscribed for 78.7 percent of the shares in the issue. On the same day, a three day payment period for the shares began. The guarantor did not fulfill their guarantee by paying on time, nor did the payment occur within a reasonably close connection to the stipulated payment period. The company disclosed information about the payment delay only on February 26, 2024.

The Disciplinary Committee noted that information about the guarantor not paying on time, or within a reasonably close connection to the stipulated payment period, constituted inside information according to the EU Market Abuse Regulation, and that the company did not disclose this inside information as soon as possible.

The Disciplinary Committee noted that the company thereby violated Article 17.1 of the EU Market Abuse Regulation and item 4.1.1 of the rulebook. The Disciplinary Committee considered the violation to be serious, and therefore a fine was imposed. The Disciplinary Committee set the fine at three annual fees.

Decision by the Disciplinary Committee regarding DORO AB

The Disciplinary Committee of Nasdaq Stockholm found that DORO AB breached the Nordic Main Market Rulebook for Issuers of Shares and therefore ordered the company to pay a fine equivalent to two annual fees.

The Disciplinary Committee found that the company had violated Article 17 of the EU Market Abuse Regulation and the rulebook by delaying the disclosure of information regarding a counterparty's changed stance on the acquisition of a subsidiary of the company, despite the information being in clear contrast to what the company had previously disclosed. According to the Disciplinary Committee, there were no grounds for delaying the disclosure under Article 17.4 (b) of the EU Market Abuse Regulation.

Decision by the Disciplinary Committee regarding QUIA PHARMA AB (publ)

The Disciplinary Committee of Nasdaq Stockholm found that QUIA PHARMA AB (publ) had breached the rules of Nasdaq First North Growth Market and therefore ordered the company to pay a fine equivalent to five annual fees.

On January 17, 2024, the company announced that it had entered into a letter of intent with Net Zero Infrastructure PLC ("NZI") regarding the licensing of the company's intellectual property. The press release included a reference to the fact that the information was such that the company was obliged to disclose it under the EU Market Abuse Regulation. The Disciplinary Committee noted that it had already become clear at an early stage that there was significant uncertainty about whether NZI had the financial means to fulfill the licensing agreement that the company and NZI were to negotiate. According to the Disciplinary Committee, information about NZI's financial conditions was necessary to enable a complete and correct assessment and should have been disclosed by the company according to Article 17.1 of the EU Market Abuse Regulation. The company did not do this and violated Article 17.1 of the EU Market Abuse Regulation and item 4.1.1 of the rulebook.

In the case, the Exchange argued that the company in several serious respects had violated the rulebook in a manner that was likely to damage public confidence in the Exchange, First North Growth Market, and the securities market in general. The Exchange had requested that the Disciplinary Committee decided to delist the company's shares.

The Disciplinary Committee found that the company had violated Article 17.1 of the EU Market Abuse Regulation and thereby item 4.1.1 of the rulebook in one respect. The Disciplinary Committee considered the violation to be serious, and therefore a fine was imposed. In relation to the other violations of the rulebook alleged by the Exchange, the Disciplinary Committee noted that the

company's information disclosure and actions collectively deserved criticism, but that the company, based on evidence presented in the case and given the design of the rulebook, cannot be considered to have violated the rulebook in most respects as alleged by the Exchange. Against this background, the Disciplinary Committee ordered the company to pay a fine equivalent to five annual fees.

Decision by the Disciplinary Committee regarding Rolling Optics Holding AB

The Disciplinary Committee of Nasdaq Stockholm found that Rolling Optics Holding AB had breached the rules of Nasdaq First North Growth Market and therefore ordered the company to pay a fine equivalent to three annual fees.

On May 20, 2024, the company announced the outcome of an arbitration between the company and a former business partner. The dispute concerned two agreements between the parties that the company terminated in April 2023. The arbitration award was issued on May 16, 2024. The Company assessed that it needed time to fully understand the significance of the award for the Company and what information should be disclosed to the market. The company decided to delay its disclosure of the inside information and called a board meeting to address the issue, which was held on the evening of May 19, 2024.

While the Disciplinary Committee acknowledged the company's assessment, it maintained that the analysis of the arbitration award did not necessitate convening and holding a formal board meeting. Even less so, there were no grounds to delay the disclosure of information until the morning after the board meeting. Against this background, the Disciplinary Committee's assessment was that the company's decision to postpone the announcement of the relevant insider information was not in accordance with Article 17.4 of the EU Market Abuse Regulation, and the information was therefore not disclosed in a timely manner. The company had thus violated item 4.1.1 of the rulebook. The Disciplinary Committee considered the violation to be serious and therefore ordered the company to pay a fine equivalent to three annual fees.

Disciplinary Committee Decisions Helsinki

Decision by the Disciplinary Committee regarding Citigroup Global Markets Europe AG

The Disciplinary Committee of Nasdaq Helsinki Ltd imposed a reprimand and a fine of EUR 350,000 to Citigroup Global Markets Europe AG due to the breaches of the Nordic Member Rules of Nasdaq Helsinki Ltd. Citigroup Global Markets Europe AG ("CITI") had breached the Rules as the trading member of the Exchange in relation to the market incident occurred in May 2022.

The Disciplinary Committee found in its decision, in summary, that CITI breached five items of the rules. The most serious violation pertained to CITI's deficiencies in its pretrade controls related to algorithmic trading, which enabled the submission of an erroneous and excessively large order that subsequently led to a significant market disruption and a severe trading incident. In light of this, the Disciplinary Committee regarded CITI's breach as a serious one.
