NASDAQ OMX Commodities and N2EX Physical Power

Oslo, 8 September 2014

Power Trading Results in August 2014:

In August 2014, the total volume in power derivatives cleared on NASDAQ OMX Commodities amounted to 119.9 TWh (August 2013: 93.0 TWh). The share traded on the exchange, NASDAQ OMX Commodities Europe, was 67.9 TWh (August 2013: 55.9 TWh). The total volume includes 4.0 TWh from German Power. (August 2013: 0.8 TWh).

In August 2014, physical power trading on the N2EX market accounted for a total of 9,929 GWh (August 2013 11,123 GWh). The total volume includes 9,928 GWh from the Auction Market and 2 GWh from the Prompt Market (August 2013: 10,956 GWh/167 GWh).

Carbon Trading Results in August 2014

In August 2014 the total volume of traded and cleared EUAs and CERs was 0.5 million tonnes as compared to 0.1 million tonnes in August 2013.
