NASDAQ OMX Commodities and N2EX Physical Power

Oslo, 3 June 2014

Power Trading Results in May 2014:

In May 2014, the total volume in power derivatives cleared on NASDAQ OMX Commodities amounted to 102.1 TWh (May 2013: 112.9 TWh). The share traded on the exchange, NASDAQ OMX Commodities Europe, was 59.5 TWh (May 2013: 56.1 TWh). The total volume includes 4.9 TWh from German Power. (May 2013: 2.2 TWh).

In May 2014, physical power trading on the N2EX market accounted for a total of 12,028 GWh (May 2013 11,205 GWh). The total volume includes 12,026 GWh from the Auction Market and 2 GWh from the Prompt Market (May 2013: 10,976 GWh/229 GWh).

Carbon Trading Results in May 2014

In May 2014 the total volume of traded and cleared EUAs and CERs was 0.3 million tonnes as compared to 0.2 million tonnes in May 2013.
