Power Trading Results in November 2015

In November 2015, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 134.9 TWh (November 2014: 147.7 TWh). The share of Order Book traded power was 74.1 TWh (November 2014: 89.4 TWh) which includes 15.2 TWh from German Power. (November 2014: 7.5 TWh).

Carbon Trading Results in November 2015

In November 2015 the total volume of traded and cleared EUAs and CERs was 0.5 million tonnes as compared to 0.6 million tonnes in November 2014.
