Power Trading Results in December 2016

In December 2016, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 105.1 TWh (December 2015: 137.5 TWh). The share of Order Book traded power was 60.0 TWh (December 2015: 74.8 TWh) which includes 9.0 TWh from German Power (December 2015: 8.4 TWh).

Carbon Trading Results in December 2016

In December 2016 the total volume of traded and cleared EUAs and CERs was 0.30 million tonnes as compared to 0.33 million tonnes in December 2015.
