Power Trading Results in May 2016

In May 2016, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 146.3 TWh (May 2015: 109.0 TWh). The share of Order Book traded power was 76.1 TWh (May 2015: 60.9 TWh) which includes 14.2 TWh from German Power. (May 2015: 7.1 TWh).

Carbon Trading Results in May 2016

In May 2016 the total volume of traded and cleared EUAs and CERs was 0.1 million tonnes as compared to 0.4 million tonnes in May 2015.
