Power Trading Results in July 2017

In July 2017, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 53.5 TWh (July 2016: 65.9 TWh). The share of Order Book traded power was 28.7 TWh (July 2016: 40.1 TWh) which includes 4.4 TWh from German Power (July 2016: 8.5 TWh).

Electricity Certificates Trading Results in July 2017

In July 2017 the total volume of traded and cleared Electricity Certificates was 0.74 million El-Certs as compared to 0.61 million El-Certs in July 2016. The share of Order Book traded El-Certs was 0.01 million El-Certs (July 2016: 0.02 million El-Certs).

Carbon Trading Results in July 2017

In July 2017 the total volume of traded and cleared EUAs was 0.02 million tonnes as compared to 0.14 million tonnes in July 2016.
