Power Trading Results in May 2019

In May 2019, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 54.8 TWh. The share of Order Book traded power was 26.5 TWh which includes 1.7 TWh from German Power.

Electricity Certificates Trading Results in May 2019

In May 2019 the total volume of traded and cleared Electricity Certificates was 1.73 million EI-Certs.

Carbon Trading Results in May 2019

In May 2019 the total volume of traded and cleared EUAs was 0.163 million tonnes.
