The Nasdaq Priva Index (the “Index” or “Priva”) is an equity strategy that tilts exposure between mega-cap, large-cap, and mid-cap Nasdaq indexes based on changes in inflation and interest rates.



Who is this index designed for

The Nasdaq Priva Index was built to offer investors more resilient equity market exposure and consistent equity-like returns within index-linked products. The Index allocates between multiple Nasdaq indexes and targets 12% annualized volatility.

Tactical Tilts

The Index uses a regime signal to tilt its allocation toward emerging stocks (NGXT) when rates and inflation are relatively low or mega-cap stocks (NDX30T) when rates and inflation are relatively high.

Rapid Rebalancing

To maintain the 12% target volatility, Priva analyzes intraday data points to rapidly rebalance and adjust its equity exposure up or down based on short-term volatility trends determined by the truVol® Risk Control Engine.

Performance Control

The Index applies a performance control mechanism with the goal of higher participation rates in index-linked products.

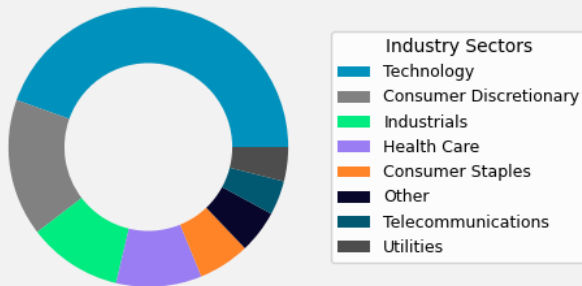
