Underlying Index

Nasdaq-100 Total Return™ (XNDX™)

Exposure Ratio

Use truVol® to estimate XNDX volatility and scale the exposure with cash (or leverage up to 200%) to target the specified level of volatility.

Dynamic Risk Scaling

Adjust the exposure of XNDX up or down by 15% based on short-term volatility trend determined by the truVol® Dynamic Risk Scalars.

Volatility Adjustment Factor

Adjust the final exposure based on trailing volatility of the index itself to maintain the specified volatility level.

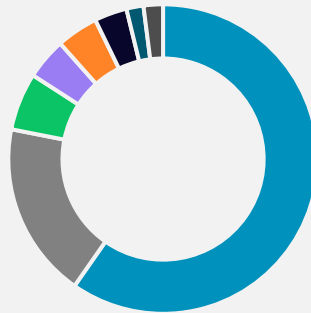
